RESERVATION

1. **Deposit** - A deposit of \$300 per person is required at the time of booking of the reservation. Reservation will automatically be cancelled if the deposit is not received by PEONY TOURS within 7 days after booking of the reservation.
2. **Final Payment** -
 - a) **Land Only Packages:** The balance of the price must be paid at least 60 days prior to the departure date. If you book less than 60 days prior to the departure date, the final payment will be due upon booking. PEONY TOURS have the right to cancel your booking and retain any deposit if the balance is not paid by the due date.
 - b) **Land & Air Packages:** The balance of the price must be paid at least 60 days prior to the departure date. PEONY TOURS may require earlier payment of the airfare portion of your tour. If you book less than 60 days prior to the departure date, the final payment is due upon booking. If the balance is not paid by the due date then PEONY TOURS have the right to cancel your booking and retain any deposit, cancel any airfare from your Land and Air Package, and change your reservation to a Land Only Package. You will be charged a late payment fee of \$50 per person for each late payment we receive.

CANCELLATION

If you cancel your booking a per person fee will be charged according to the date we receive and acknowledge your cancellation as follows:

- **Cancellation Notice:** Written notice of cancellation must be received by PEONY TOURS either by personal delivery, mail, fax, or e-mail. Your notice of cancellation will only be effective when it is received in writing by us and acknowledged.
- **Third Party Suppliers' Penalties and Charges:** In addition to the above stated cancellation charges, if tickets or vouchers for airlines, hotels, cruises, trains or any relevant third-party supplier have already been issued or confirmation of service has been received at the time of cancellation (regardless of number of days prior to departure), the traveler will be wholly liable for any additional airline, hotel, cruise line, or train cancellation penalties and service charges pursuant to suppliers' rules and regulations.
- **Single Room Supplement Charge:** In the event of cancellation by your travel companion or roommate, you will be responsible for the additional resultant single supplement charge.
- **Airline Tickets:** PEONY TOURS reserves the right to have the airline tickets issued by PEONY TOURS or its authorized agent immediately upon receipt of your tour deposit.
- **Certain Arrangements:** Certain arrangements with third-party suppliers may not be able to be amended after they have been confirmed and any alteration may incur a cancellation charge to you of up to 100% of that part of the arrangements.
